

## **Job Description - Class Teacher**

Core Purpose	<ul> <li>Maintain and contribute to the ethos of the school.</li> <li>To be responsible to the whole school community with the school's values and aims at the heart of your work.</li> <li>To be accountable for ensuring that all pupils enjoy and benefit from a high quality education and for contributing to the education service more widely.</li> <li>To carry out your responsibilities, and accept your accountability to a wide range of groups, particularly pupils, parents, carers and management.</li> <li>Teach pupils in accordance with the curriculum to the highest possible standards.</li> <li>Ensure that each pupil achieves their full potential. Have the highest expectations of every child, believing that every learner has an unlimited potential for development.</li> <li>Carry out the professional duties of a teacher under the direction of management.</li> <li>Take part in school events and extra-curricular activities.</li> </ul>
Key Responsibilities and Activities	<ul> <li>Key responsibilities as according to national standards include:</li> <li>To be an effective class teacher providing for the range of needs of the children within the class.</li> <li>Plan to deliver the curriculum within the framework of current school policies, both in the short and long term planning structures.</li> <li>To set high expectations and standards and monitor and evaluate the effectiveness of learning to enable all pupils to become effective, enthusiastic, independent learners, committed to life-long learning.</li> <li>To work with the Academy, Trust and others and assist in implementing a shared vision and strategic plan that inspires and motivates pupils, staff, and all other members of the school community.</li> <li>Use of data to monitor and evaluate progress, support pupils, raise attainment and ensure pupils reach their full potential and targets.</li> <li>Keep detailed records of the progress of each child in line with policy.</li> <li>Plan and resource the classroom as appropriate to encourage the development of all aspects of pupils' learning.</li> <li>To work collaboratively with parents, carers and staff for the achievement and wellbeing of all pupils.</li> </ul>
